Steve Carstensen, DDS, has treated sleep apnea and snoring in Bellevue, WA since 1998. He's the Consultant to the ADA for sleep-related breathing disorders and heads the ADA's Children's Airway Initiative. He trained at UCLA's Mini-Residency in Dental Sleep Medicine and is a Diplomate of the American Board of Dental Sleep Medicine. He lectures internationally and directs sleep education at Airway Technologies and the Pankey Institute, in addition to advising several other sleep-related manufacturers. In 2014 he helped found Dental Sleep Practice Magazine and currently serves as Chief Dental Editor. He has written chapters for several related textbooks. In 2019, A Clinician's Handbook for Dental Sleep Medicine, written with a co-author, was released. The second edition is soon to be published by Quintessence. The AADSM awarded him the 2023 Distinguished Service Award.
